## 2014 YOUTH ART DIVISION INFORMATION SHEET



~The Youth Art Division is open to youth artists, 6-18 years old. Artists under 13 must be chaperoned by an adult at all times at the festival.

~**NEW SHARED BOOTH RULES!** Two exhibitors may be in one booth if both artists have worked together on the artwork. These artists will receive an extra large booth space (10'X10') **as space allows. Participation and booth fees (\$60.00) are per artist.** Fees may not be split by the two artists. Fees go to help defray the production, advertising and security costs of this event.

~Fees are non-refundable unless space is not available. If a space is not available, the fee will be refunded in full.

~Artists may display & sell original art made completely by the artist only.

~All types of original art may be shown: painting, drawing, jewelry, ceramics, prints, fiber, sculpture, photographs, glass and mixed media.

~Artists are accepted in order of application receipt. Space is limited.

~Artists will provide their own set-ups such as tables, easels, display boards, chairs, etc. Please bring something which can provide you with shade and protection from any possible rain. All tables must be covered to the ground with cloth or other material. Spaces are approximately 5x5

\*The nicer your display looks, the more people will want to stop and look at your artwork! Think of how stores you like look. . . neat, organized, creative, and colorful. Signs and prices should be neatly and clearly written.

~The festival will run rain or shine, August 24th and 25th. Artists are expected to stay for full show hours on both days: 10am-6pm. If an artist leaves early they will not be allowed to participate in future festivals.

~Artists must check-in on the Saturday morning of the festival, between 8-9am, in the festival office on the south plaza of Port Clinton Square, near "Waves" beauty shop. Official artist badges, festival materials, and parking passes will be distributed there.
